CITY ADMINISTRATOR REPORT - MARCH 2024

Over the past two decades, the area situated between Oconto Road to the south and West Flanner Road to the north has experienced significant residential growth. It all began in 2004 with the development of the 29-lot Maple Ridge Heights Subdivision (Avanti Drive), followed by the Schlei Subdivision (21 lots), Maple Ridge Estates Apartments (108 units), River View on Maple Ridge Subdivision (25 lots), and most recently, the Jackson Woods Subdivision (19 lots).

Since the onset of residential development in this region, the City Parks & Recreation Commission has been planning to establish a neighborhood park for the benefit of the area's residents. In April 2022, the Commission approved a conceptual plan for a new neighborhood park on an approximately 4-acre parcel, located north of Maple Ridge Road and adjacent to the west end of the new Maple View Drive. The park plan includes amenities such as playground equipment, a basketball court, picnic shelter, restrooms, green space, a dog park area and a parking lot. Additionally, the City may consider installing pickleball courts within the park.

City staff is currently planning to commence development of the new park this year. The initial phase will involve installing the parking lot area and a granite walking path, expected to be completed this spring. The walking path will encircle the eastern half of the park initially, with plans to expand it as the western half of the park is developed in the future. The playground equipment will be installed as funding allows, with efforts to seek financial assistance from local community organizations and area foundations. The City's funding for the new park improvements will be drawn from accumulated cash-in-lieu of land dedication fees from the residential developers of this area, and also from the accumulated portion of building permit fees that have been placed in the Parks & Recreation Capital Reserve Fund.

The Parks & Recreation Commission has also identified the need to stabilize the shoreline at River Park. The Commission will be considering a proposal to install rip-rap materials along about 100 feet of the River Park shoreline by the end of this summer at their March 19th meeting. This shoreline stabilization project, anticipated to span multiple years, will also be financed through the Parks & Recreation Capital Reserve Fund.
